<PROCEDURE>

1. Mix all ingredient using pestle and mortar to grind the powder material.

<INSTRUCTIONS OF USE>

For 1 part of powder add 7 parts of hot water (in order to ensure all ingredients solubilization, especially Amisoft® HS-11P) and mix until it is homogeneous. Apply the product on skin after it is at room temperature.
